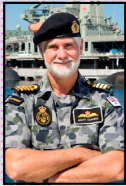

General **Aleisha Woodward.**

Immediately prior to her assignment to Australia, Aleisha completed a master's program in national security strategy at the National War College.

Her previous assignments in Washington DC were in the Office of Australia, New Zealand, and Pacific Islands, where Aleisha worked primarily on Australian issues, including the U.S.– Australia 12 Month Work and Travel Pilot Programme and the U.S.– Australia-Japan Trilateral Strategic Dialogue; and as a Senior Watch Officer in the Department of State's Operations Centre.

Overseas Aleisha worked as the Press and Cultural Attache at the U.S. Embassy in Moldova; a Consular Officer in London, and a Public Diplomacy Officer in Tokyo coordinating conferences and seminars on American society and foreign policy related topics.

Aleisha speaks Japanese and Romanian, and can shop in Spanish and French.

Aleisha received undergraduate and graduate degrees in international relations from Brigham Young University in Provo, Utah.

1. The composer of the **tune** of the National Anthem of the United States of America was an **Englishman!** He was **John Stafford Smith** (1750—1836) composer and organist of the Chapel Royal, London, who's father, Martin Smith was organist of Gloucester Cathedral.

**Merv Bailey** (Treasurer/Membership Officer) born to farmers in the Wubin/Dalwallinu wheat growing area. Merv has been married three times; has 4 daughters; a son, and 11 grandchildren.
